Definitions:

1. **Residents at Risk of Wandering:** any resident with a long-term memory deficit or any other condition where a resident has demonstrated a tendency to wander. This includes, but is not limited to, conditions such as Alzheimer Disease, stroke, etc.
2. **Specialized Care:** health care services provided by health care professionals that are required by a resident, but does not include personal care.
3. **Authorized Capacity:** the maximum number of residents permitted to be accommodated in a home as stated on the licence.
4. **Conditions:**
 - All licences have a condition that requires them to operate in accordance with the most recent edition of the Licensees' Handbook.
 - Other conditions on a licence may: clarify what care can and cannot be provided in the home, identify actions that the licensee is taking, etc.
5. **Light Care:**
 - Resident is independent with personal care. May need reminders and cueing.
 - Minimal specialized care (e.g. supervising a resident with their own specialized care).
 - Independent with transfers and mobility.

6. Intermediate Care:

- Supervision of behaviour.
- Supervision and some assistance with personal care.
- Assistance with specialized care.
- Supervision and/or one person assist transfers and/or mobility.

7. Heavy Care:

- Frequent supervision of resident due to emotional, behavioural or physical needs (e.g. palliative).
- Direct assistance with all personal care.
- Two person assist or mechanical lift with transfers and/or mobility.
